Midterm Overview

The Midterm exam is a test covering the first four units of study; it is broken up into three parts: firstly, an objective exam where students are tested on their command of simple historical facts (see immediately below); secondly, the completion of a listening and responding (see course website); and lastly, the completion of an assignment where students must assess the reliability of a secondary source (see Assignment 5 on the course website).

Exam Breakdown

Part 1: Objective Exam (25%)

Part 2: Listening & Responding (50%)

Part 3: Writing & Analysing (25%)

Part 1: The Objective Exam

The conventional exam requires students to both answer a series of typical objective questions like matching, multiple choice, multiple correct, etc. but also unconventional questions like synectical multiple choice. Below are some examples of what a synectical multiple choice question looks like.

Synectical multiple choice questions require students to identify a relationship or something in shared in common between two things. See example below:

- **Ex. 1**. Paul is to Christianity what _____ is to Islam.
 - a). Charlemagne
 - b). Innocent III
 - c). Muhammed
 - d). Constantine

Answer: Paul is to Christianity what <u>Muhammed</u> is to Islam. The relationship or connection Paul and Muhammed share is they were both responsible for making converts of people to their respective religions.
